### HOW IT WORKS

The Town of Cottage City is planning a Dumpster Weekend in November! More information regarding the date and time will be provided in next month's newsletter.

The Town of Cottage City is proud to announce the receipt of the following two grants:

- Chesapeake Bay Trust Urban Trees Award Program in the amount of \$20,300.
- United States Dept. of Agriculture (USDA) Community Facility Grant in the amount of \$39,500.

The goal of the Urban Tree Grant Program is to green communities; enhance quality of life, human health, and community livability by improving air quality and reducing urban heat island effect; and mitigate some of the effects of climate change. The award will be used to plant trees throughout Cottage City.

USDA Community Facilities Programs offer direct loans, loan guarantees and grants to develop or improve essential public services and facilities in communities across rural America. The funds will be used to purchase a vehicle for the police depart which will be a 2022 Hybrid Ford Explorer Interceptor AWD to help reduce the carbon footprint within our community.

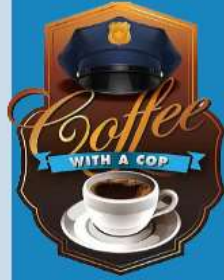
¡La ciudad de Cottage City está planeando un día de basura en noviembre! Se proporcionará más información en el boletín del próximo mes.

La ciudad de Cottage City se enorgullece en anunciar la recepción de las siguientes dos subvenciones:

- Programa de adjudicación de árboles urbanos de Chesapeake Bay Trust por un monto de \$20,300.
- Subvención para instalaciones comunitarias del Departamento de Agricultura de los Estados Unidos (USDA) por un monto de \$39,500.

El objetivo del Programa de Subsidios para Árboles Urbanos es hacer que las comunidades sean más ecológicas; mejorar la calidad de vida, la salud humana y la habitabilidad de la comunidad al mejorar la calidad del aire y reducir el efecto de isla de calor urbano; y mitigar algunos de los efectos del cambio climático. El premio se utilizará para plantar árboles en todo Cottage City. Los Programas de Instalaciones Comunitarias del USDA ofrecen préstamos directos, garantías de préstamos y subvenciones para desarrollar o mejorar los servicios e instalaciones públicos esenciales en las comunidades de las zonas rurales de Estados Unidos. Los fondos se utilizarán para comprar un vehículo para la salida policial, que será un Ford Explorer Interceptor AWD híbrido 2022 para ayudar a reducir la huella de carbono dentro de nuestra comunidad.

## **NOISE COMPLAINTS** **COTTAGE CITY CODE 6-1 NOISE**



*The Commission of the Town of Cottage City hereby declares it to be the public policy of the Town that every person is entitled to an environment free of noise levels which are detrimental to life, health and enjoyment of property. The following requirements state the lawful and unlawful limits of noise within the Town of Cottage City, as well as the enforcement procedures and requirements related to noise:*

### Noise prohibitions.

- It shall be unlawful for any person, whether a homeowner, owner, tenant, firm, or corporation, to allow on owned or occupied, any noise or sound level that exceeds the maximum permissible sound level or is in violation of this section.

### Violation:

- Any continuous noise audibles from a distance of 50 feet or less from either the source or the noise or the property that is the source of the noise at any time, or from the hours of 9:00 pm to 8:00 am the distance is 40 feet.

### Enforcement:

- The alleged violator or the owner of the source of noise in question shall be advised verbally or in writing, by a representative of the Town or County of the nature of the alleged violation and shall be warned and ordered to cease the violation and not repeat it or else be subject to fine or other penalty. If the violation fails to cease or should repeat, then a fine of \$50 may be issued to the violator or owner and a fine of \$500 may be issued for each repeat offense that occurs within one calendar year after the first offense.


### Exception procedure:

- A person may request an exemption or permit, to have an event (cookout, party, or other gathering) that may have noise exceeding the allowed regulations. This request must be sent to the Town Manager for approval. For more information contact Town of Cottage City Main Office at 301-779-2161 or the Cottage City Police Department at 301-927-9225.

# COTTAGE CITY

## EMERGENCY RELIEF FUND FOR FAMILIES

The purpose of this program is to provide financial assistance to eligible Town of Cottage City individuals and families who have been directly impacted by the COVID-19 pandemic. Payments will be sent directly to the related vendor.

### Eligibility

- Must be a Cottage City resident
- Must show proof of hardship
- The applicant must provide a bill statement that they would like to be paid (**Acceptable Bills: Rent/ Mortgage/ Water/ Electric/ Natural Gas**)
- No Funds will be given to the applicant. All bills will be paid directly to the outstanding account.
- Town of Cottage City property taxes and other Town bills/ obligations are not eligible

### Requirements

- Completed application form with required documentation
- Proof of residency may be established through any **two\*** of the following:
  - Sign copy of a deed, mortgage, or lease agreement
  - Utility bill with applicant's name and address, issued within the last 60 days
  - Bank statement issued within the last 60 days
  - Current, valid insurance policy
  - Recent voter registration card
  - Government benefits statement
  - Government ID Card/Driver's License with address
- Proof of hardship (include any of the following documentation):
  - Confirmation of rent, mortgage, or utility delinquencies on letterhead from interested party (a copy of the bill will suffice if it shows the delinquencies)
  - Letter or documentation from former employer
  - Signed statement pertaining to COVID-19 impact or non-essential status for 1099 (contract) workers or self-employed individuals
  - 2019 and/or 2020 tax return(s) as filed with the IRS
  - Documentation of acceptance under other Government financial aid programs
  - Proof of unemployment benefits or application
  - Letter of furlough or layoff from employer
  - Receipt of SNAP/TANF benefits
  - Receipt of Social Security Income
  - Medicaid
  - Residing in subsidized housing
  - Family eligible for free/reduced lunch at schools

### Elegibilidad

- Debe ser residente de Cottage City
- Debe mostrar prueba de dificultad
- El solicitante debe proporcionar un estado de cuenta de que le gustaría que se le pague. (**Facturas Aceptables: Renta/ Hipoteca/ Agua/ Electricidad/ Gas Natural**)
- No se entregarán fondos al solicitante. Todas las facturas se pagarán directamente a la cuenta pendiente.
- Los impuestos a la propiedad de la ciudad de Cottage City y otras facturas/obligaciones de la ciudad no son elegibles

### Requisitos

  - Extracto bancario emitido dentro de los últimos 60 días
  - Póliza de seguro actual y válida
  - Credencial de elector reciente
  - Declaración de beneficios del gobierno
  - Tarjeta de identificación del gobierno/licencia de conducir con dirección
- Prueba de dificultad económica (incluya cualquiera de los siguientes documentos):
  - Confirmación de morosidad de alquiler, hipoteca o servicios públicos en papel con membrete de la parte interesada (una copia de la factura será suficiente si muestra la morosidad)
  - Carta o documentación del antiguo empleador
  - Declaración firmada relacionada con el impacto de COVID-19 o el estado no esencial para trabajadores 1099 (contratados) o personas que trabajan por cuenta propia
  - Declaración de impuestos de 2019 y/o 2020 tal como se presentó ante el IRS
