RESOLUTION 2019-11

A RESOLUTION OF THE COTTAGE CITY COMMISSION APPROVING THE MAKING OF COTTAGE TERRACE BETWEEN 37TH AND 38TH AVENUES AND 37TH AVENUE BETWEEN THE ALLEY EXIT AND COTTAGE TERRACE INTO A ONE-WAY STREET, GOING FROM THE ALLEY TO COTTAGE TERRACE ON 37TH AVENUE AND THEN ON COTTAGE TERRACE TOWARD 38TH AVENUE.

WHEREAS, pursuant to Section 66 of the Town Charter, the Town has control of all public ways in the Town except those that are under the jurisdiction of the State Highway Administration, and subject to the laws of the State of Maryland and said charter, the Town may do whatever it deems necessary to establish, operate, and maintain in good condition the public ways of the Town; and

WHEREAS, Section 25-102 of the Transportation Article ("TR Art.") of the Maryland Code grants to the legislative body of every local authority in Maryland, including the Town of Cottage City, general power to regulate traffic by means of traffic control devices, to designate roadways as one-way highways, and to adopt such other traffic regulations as are allowed by law; and

WHEREAS, Section 25-104 of the TR Art. states that the State Highway Administration shall adopt a manual and specifications for a uniform system of traffic control devices, consistent with the provisions of the Maryland Vehicle Law, for use on highways in this State, and that this uniform system shall correlate with and, as far as possible, conform to the system set forth in the most recent edition of the Manual on Uniform Traffic Control Devices for Streets and Highways; and

WHEREAS, Section 25-109 of the TR Art. grants to the legislative body of every local authority in Maryland, including the Town of Cottage City, as to highways under its jurisdiction, general powers to designate through highways and place appropriate signs at specified locations; and

WHEREAS, Section 25-106 of the TR Art. states that "[o]n every highway under its jurisdiction, a local authority shall place and maintain those traffic control devices that it considers necessary to carry out the provisions of the Maryland Vehicle Law or local traffic ordinances or to regulate, warn, or guide traffic [and] each of these traffic control devices shall conform to the manual and specifications of the State Highway Administration," and

WHEREAS, Section 6-9, having the catchphrase of "Peace and Good Order," of the Code of the Town of Cottage City (the "Town Code") requires that all persons must obey all rules and signs posted by authority of the Town on public property and rights of way; and

WHEREAS, Section 9-4, having the catchphrase of "Parking signs, traffic control devices, and notices," of the Town Code, as amended, authorizes the Cottage City Commission to erect such signs, traffic control devices and notices regarding parking and traffic for the common good but that the order to take such action shall be issued by ordinance or written resolution and said ordinance or resolution or a fair summary thereof shall be published in the Town newsletter or a newspaper of general circulation in the Town; and

WHEREAS, the Cottage City Commission finds that the regulation of vehicular traffic is necessary to promote pedestrian and traffic safety, to advise motorists of the proper and safe use of the Town's roadways, to protect the public and the residents from hazardous conditions, and to accomplish other purposes in furtherance of the public health, safety and welfare.

NOW, THEREFORE, BE IT RESOLVED by Cottage City Commission, that the following actions and/or traffic control devices are hereby approved and ordered:

A. Placing two signs on either side of the southwest entrance to Cottage Terrace at 38th Avenue, facing 38th Avenue, that read "ONE-WAY – DO NOT ENTER," so that traffic coming from either direction will be appropriately warned not to enter Cottage Terrace from 38th Avenue;

B. Placing a BEGIN ONE-WAY sign with a right-directed arrow on 37th Avenue across from the alley exit between Parkwood and Cottage Terrace;

C. Placing another ONE-WAY sign with a right-directed arrow on Cottage Terrace across from the corner of 37th Avenue and Cottage Terrace;

D. Placing a sign on the southwest side of 37th Avenue, between the addresses 3808 and 3810, with a large "P" in a circle above the word "Parking," with a large right-directed arrow below the word; and

E. Removing the sign on Cottage Terrace with the left-turn arrow.

BE IT FURTHER RESOLVED that a fair summary of this Resolution shall be published in the Town newsletter and on the Town website within 30 days of the effective date of this Resolution.


BE IT FURTHER RESOLVED that the Commissioner-Chairman shall be authorized to sign this Resolution on behalf of the Commission.


